STUDY PROGRAMME IN ENGLISH FOR WHICH A CALL HAS BEEN ANNOUNCED:

Master academic studies:

- **Public health, in English (60 ECTS)**
- **Bioethics, in English (60 ECTS)**
- **Physical Activity Health and Exercise Therapy, in English (60 ECTS)**
- **Medical Longevity and Healthy Aging, in English (60 ECTS)**

NUMBER OF VACANCIES FOR STUDENTS:

CONDITIONS:

The requirement for enrollment in the first year of the Public Health study programme is a previously achieved scope of undergraduate studies of at least 240 ECTS or completed integrated academic studies, i.e., master academic studies, with at least 300 ECTS or higher education lasting at least 8 semesters according to the regulations that were valid until the enactment of the Law on Higher Education, in the following fields: health, law, economics, organizational sciences, political sciences, philosophy, pedagogy and andragogy, psychology, sociological sciences, special education and rehabilitation, physics, physics-chemical, chemical sciences, architecture, civil engineering, electrical engineering and mechanical engineering. Knowledge of English and computer skills are required.

The requirement for enrollment in the first year of the Bioethics study programme is a previously achieved scope of undergraduate studies of at least 240 ECTS or completed integrated academic studies, i.e., master academic studies, with at least 300 ECTS or higher education lasting at least 8 semesters according to the regulations that were valid until the enactment of the Law on Higher Education, in the following fields: medicine, dentistry, pharmacy, veterinary medicine, special education and rehabilitation, pedagogy, andragogy, psychology, social work and law. Knowledge of English and computer skills are required.

The requirement for enrollment in the first year of the Physical Activity, Health and Exercise Therapy study programme is a previously achieved scope of undergraduate studies of at least 240 ECTS or completed integrated academic studies, i.e., master academic studies, with at least 300 ECTS or higher education lasting at least 8 semesters according to the regulations that were valid until the enactment of the Law on Higher Education, in the following fields: medicine, physical education and sport, special education and rehabilitation and psychology.

The requirement for enrollment in the first year of the Medical Longevity and Healthy Aging study programme is a previously achieved scope of undergraduate studies of at least 240 ECTS or its equivalent, i.e. higher education in the field of healthcare (medicine, pharmacy, dentistry, veterinary medicine, special education, etc.) or social and humanistic sciences (sport and physical education, psychology, etc.) with the interest in the aging process. Knowledge of English and computer skills are required

Prerequisite for enrollment in a study program conducted in English is proof of knowledge of English at a higher intermediate level of competence = B2 - Cambridge Advanced Certificate in English (CAE) or IELTS (International English Language Testing System) or completed high school education in English.

CRITERIA FOR DETERMINING THE ORDER OF CANDIDATES ON THE RANKING LIST:

The order of candidates for enrollment in the first year for the Public Health, **Bioethics, Physical Activity Health and Exercise Therapy, Medical Longevity and Healthy Aging,**

study programme:

- overall average grades (up to 60 points),
- duration of study (up to 10 points) and
- motivational interview (up to 30 points).

The duration of the studies is assessed with a maximum of 10 points.

The duration of the studies is scored based on the time it took the candidate to complete the scored study programme after the expiration of the regular graduation deadline. The time of extended studies is calculated as a percentage in relation to the maximum extension of studies, after which the candidate is awarded an inversely proportional percentage of points of a maximum of 10.

As an example, if the maximum extension of studies is 4 years, and the candidate extended the studies by 3, he/she used 75% of the possible extension and will be awarded 25% of the maximum number of points, or 2.5 of the maximum 10 points.

Motivational interview is evaluated:

- motivation to study: 1, 2, 3, 4, 5,
- creativity: 1, 2, 3, 4, 5,

- general impression: 1, 2, 3, 4, 5.

The grade given by the members of the commission is multiplied by two. The evaluation is performed by a three-member commission, appointed by the Council for Specialist Teaching.
